# SPORTING POST, September 20th:

"The Rochester Punch Society are very much surprised that the men who call themselves the London Gamesters should risk the little reputation they have upon a forgery, since it would have been a much greater wonder to the numerous crowd of spectators if the Rochester men had not beaten all those bragging hectors, but no gamesters, than that three of their men should not be able to bear the violence of the rains, which fell so heavy it was impossible to continue the game. To convince them that the Rochester men do no think they had the worst of the match, they are willing to meet eleven of the best of them, whenever they please, at Dartford in Kent, where they will play them for a guinea a head; but they think proper to give them this advice, that if they cannot choose better men than they did the last encounter, it will be but throwing away their money and they had much better stay at home. If in spite of this caution they dare venture, the Rochester men don't doubt but sprightly Punch will easily overcome foggy Ale."

The Weekly Journal of May 16<sup>th</sup>, 1719 said: "Last Week a Tryal was brought at Guildhall, before Lord Chief Justice Pratt, between Two Companies of Cricket Players, the Men of Kent, Plaintiffs, and the Men of London, Defendants, for Sixty Pounds, played for at Cricket, and after a long Hearing, and near £200 expended in the Case, my Lord, not understanding the Game, ordered them to play it over again; and they net accordingly on Monday last in Lamb's Conduit Fields, but one of the Players being taken ill, it was deferred to another Opportunity." The sequel appeared in the issue of the Weekly Journal of July 4<sup>th</sup> – "The great Match betwixt the Londoners and the Kentish Men for which there has been a famous Trial at Law, and by a Rule of Court was ordered to be played out, in which the Kentish Men had four Men to play, and to get 30 to come up with the Londoners, was played in White Conduit Fields, near Islington: the Kentish Men were bowl'd out after they had got 9, and lost the Match. 'Tis reckoned the Law Suit will amount to £200. The Match was Played for a Guinea a Man each side."

### KENT WON BY ONE WICKET.

Kent Cricket Matches: "The first fully recorded match. It was brought about by a challenge issued by Lord J. P. Sackbille, on behalf of Kent, to play against All England. England were 3 for five but Bryan and his captain pulled the game around. Among the formers hits was a 5. The wickets were pitched at 12 o'clock and the match completed in a day... The Prince of Wales, the Dukes of Cumberland ("Butcher") and Richmond, Admiral Vernon ("Old Grog") and other distinguished persons were present. Three brothers Newland – Messrs. Richard, Adam and John – played for England."

Daily Advertiser, June 30<sup>th</sup>: "It was observed by the noblemen and gentlemen there present that there was great disorder so that it was with difficulty that the match was played out. It is ordered for the future that each person pay for going into the Ground sixpence, and there will be for the better conveniency of all gentlemen that favour me with their company, a ring of benches that will hold at least 800 persons. And it is further desired that no person

whatever, except those appointed to keep order and the players engaged for the day, be admitted to walk within the ring."

This match inspired James Love to write "An Heroic Poem", which is appended to this volume.

# KENTISH POST, August 18<sup>th</sup>:

"We hear from New Romney, that on Monday next there will be play'd a Game of Cricket, Romney taking Tenterden, against Battle, for Half a Guinea a Man; Wickets to be pitch'd at Twelve. The game to be play'd out. Likewise, the Thursday after, Romney plays against Tenterden, High Halden and Warehorne, at New Romney. Wickets to be pitch'd at One of the Clock."

The two games played between England and Kent this year gave rise to a Law Suit:

Jeffreys versus Walter

B.R. 1 Wils. 220 Trinity Term 21 and 22 Geo. II 1748

Debt upon a bond: the defendant craves oyer thereof, and sets out the condition, that whereas one J. Parsons, by bond of the same date, is bound to the plaintiff in the penal sum of £1,000 to pay him an annuity of £100 per annum at the four usual feasts during their joint lives; now the condition of his obligation is such, that if J. Parsons during the joint lives of him and Jeffreys to remain in force; quibus lectic et auditis; the defendant says he ought not to be charged, because he says that after the 1st of May, 1711, and before the making of the said bond, viz, such a day and year, certain persons unknown to the defendant, who styled themselves as the county of Kent, played against certain other persons who styled themselves all England, at a certain game called cricket, and that the plaintiff won of Parsons 25 guineas on a bet upon tick upon the said game and also won of him a second bet upon another game at cricket played between the same persons the sum of 25 guineas upon tick; and that thereupon it was agreed between the said Parsons and Jeffreys that if the said Jeffreys would advance to the said Parsons £447 10s to make up the two lost bets £500 he the said Parsons would give him the said recited bond to pay him an annuity of £100 a year during their joint lives: and the defendant avers that the present bond was given by him to the plaintiff (as a collateral security) for money won at play, and that it is void by the statute. Plaintiff demurs, and defendant joins in demurrer.

It was argued for the Plaintiff that *cricket* is not a *game* within the meaning of *Stat 9 Anne* and *2ndly*, that the present bond was not given for money won at play, whatever the bond by *Parsons* might be.

For the defendant it was insisted that *cricket* is a *game* though not mentioned in the *statute* and comes under the general words *or any other game or games whatever*; it is (to be sure) a manly *game*, and not bad in itself, but it is the ill use of it that is made of it, by betting above £10 upon it, that it is bad, and against the law, which ought to be construed largely to prevent the great mischief of *excessive gaming*.

If *Parsons* bond be void, there is no doubt that the defendants bond is so too, for which was cited *Salk. 344*, a case put by Holl C.J., as in point. The court inclined to give judgement to the defendant that *cricket* is a *game*, and that the present bond is void; but it stood over for further argument, and the parties agreed, *ut audivi*.
